VVIP Infratech Limited receives ₹80.97 crore LOA

Bhadohi Sewerage & STP project under Namami Gange, awarded by UP Jal Nigam (Rural), Varanasi 18-month construction + 15-year O&M

Ghaziabad, India — 15 May 2026: VVIP Infratech Limited (“Company” / “VVIP”) has, on the date of this release, received a Letter of Acceptance (LOA) from the Office of the Superintending Engineer, Circle Office, Madhopur, Sigra, Uttar Pradesh Jal Nigam (Rural), Varanasi, for a project of aggregate contract value **₹80,97,00,344 (₹80.97 crore, inclusive of all taxes Except GST)** under the National Mission for Clean Ganga (Namami Gange Programme), on a Design, Build, Operate and Transfer (DBOT) basis.

Why this matters

- **Order book strengthens to ₹815 crore on a pro-forma basis (₹735 crore as of 30 April 2026 + ₹80.97 crore Bhadohi LOA), extending standalone revenue visibility to ~3 years.**
- Revenue mix tilts further toward annuity. The 15-year O&M tail (~25–30% of contract value over life) is recurring, lower-working-capital, and structurally higher-margin than EPC.

- Continues VVIP's franchise with UP Jal Nigam — the same counterparty that has awarded the Company prior STP/sewerage contracts at Etawah (₹120 crore DBOT), Kasganj (₹68 crore O&M) and Shahjahanpur (₹124 crore STP construction).
- Pre-qualification credentials reinforced: VVIP remains one of a small set of UP-based contractors to have executed 56 MLD SBR-technology STPs (Govindpuram and Madhuban Bapudham, Ghaziabad — both commissioned in 2013).

Management Commentary

Mr. Vaibhav Tyagi, Managing Director, said: *“Bhadohi sits squarely in the geography and the programme we know best. We have been executing under Namami Gange for over a decade — the 56 MLD plants in Ghaziabad, the 21 MLD plant in Etawah, and the 40 MLD facility at Shahjahanpur. Winning this DBOT mandate reflects the pre-qualification and execution credentials we have built with UP Jal Nigam. The 15-year O&M tail also strengthens the recurring-revenue component of our order book, which is the part of our business model we are most focused on scaling.”*

Order Book Context

Including the Bhadohi LOA, VVIP's pro-forma infrastructure order book stands at approximately **₹815 crore**, representing close to **3x FY25 standalone revenue**. The order book is diversified across three verticals: STP & Sewerage, Electrical Distribution (under RDSS) and Jal Jeevan Mission water supply — with the bulk awarded by UP Jal Nigam, Uttarakhand Peyjal Nigam, UPCL and PVVNL, all government / state-utility counterparties with AAA+ rated payment profiles.

About VVIP Infratech Limited

VVIP Infratech Limited (BSE: 544219) is a Class 'A' Civil and Electrical EPC contractor with over 25 years of execution history across Uttar Pradesh and Uttarakhand. The Company operates across four verticals: (i) Sewage Treatment Plants on SBR technology (up to 56 MLD); (ii) Sewerage networks; (iii) Water supply schemes under Jal Jeevan Mission; and (iv) Electrical distribution and sub-station works up to 33 KV. The Company has delivered 50+ projects to date with zero contract defaults, and holds approved-vendor status with UP Jal Nigam, Ghaziabad Development Authority, Lucknow Development Authority and Kanpur Development Authority.

Through its 90% subsidiary VVIP Realtech Private Limited (formerly Vibhor Vaibhav Infrahome Private Limited), the Company also operates a residential real estate business with 75 lakh sq. ft. delivered across the NCR and an active pipeline at VVIP Namah (Ghaziabad), VVIP Addresses (Greater Noida West) and Sector 22D Yamuna Expressway.
